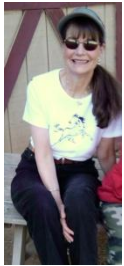

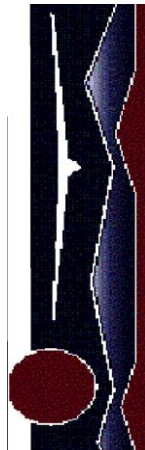

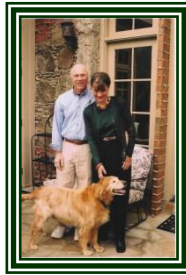

Clients are encouraged to stay in the area “for a spell” following their workshops

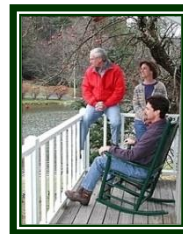

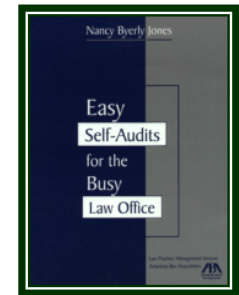
